HEALTH & SAFETY AT WORK ACT 1974

HEALTH & SAFETY POLICY OF ROPE & SLING SPECIALISTS LTD

1. GENERAL STATEMENT OF POLICY

Rope & Sling Specialists Ltd is fully aware of, and fully accepts its responsibilities, both statutory and otherwise for the health and safety of all employees and will continue to do so. RSS will, so far as is reasonably practicable take any action, which is necessary to provide:

- (a) Safe plant and maintenance of such plant
 - (b) Safe systems of work
 - (c) Sufficient information, instruction, training and supervision to ensure the health & safety at work of all employees.
 - (d) Safe arrangements for the use, handling, storage and transport of articles and substances.
 - (e) A safe place of work with safe access to and from it.
 - (f) A healthy and safe environment both internally and externally.
 - (g) Adequate facilities for welfare at work.
2. RSS will ensure as far as is reasonably practicable, that persons within their premises, but not in their employment, or persons elsewhere in contact with their products, shall not be exposed to risks to their health and safety.
 3. RSS will consult with outside organisations or competent persons on the development of policies, procedures and standards necessary for the continued protection of our external environment in line with current and future legislation.
 4. RSS will issue to every contractor, engaged within its premises, instructions detailing the safety rules applicable to contract personnel and will monitor their activities to ensure their compliance.
 5. RSS will consult with a Safety Committee, appointed by management and formed to discuss and report the whole range of health and safety matters relevant to their place of work.
 6. RSS recognises that no health and safety policy can be successful without the full co-operation of employees. Employees are reminded of their statutory duty to take reasonable care for the health and safety of themselves and other workers and to co-operate with management in the implementation of the Health and Safety Policy.
 7. Note will be taken of representatives about health and safety from any employee and remedial action will be implemented.
